ⁱ Tariff rate applicable to imports outside of the DCFTA TRQ (= the EU's MFN rate). In most cases, the out-of-quota duty is prohibitive, meaning that imports subject to the duty are not competitive and imports are therefore effectively capped at the level of the TRQ.

ⁱⁱⁱ Comparison of 2024 import levels vs revised TRQs: new TRQs / 2024 imports. For instance, the new TRQ for wheat (1.300.000 tonnes) is equivalent to 23 percent of 2024 import volumes for this product category. Given that the out-of-quota duty level (95 EUR/tonne) is prohibitive and imports of wheat from Ukraine would therefore be effectively capped at the level of the TRQ, the revised TRQ can be expected to lead to an approx. 77 percent reduction of imports vis-à-vis 2024.
